

# Commissioner Hyde-Smith Secures Important Products for Mississippi Beekeepers

Mississippi Agriculture Commissioner, Cindy Hyde-Smith, has announced approval by the United States Environmental Protection Agency (EPA) of two emergency exemptions to help Mississippi beekeepers control damaging varroa mite infestations in honey bee colonies.

The following products have received emergency exemptions under Section 18 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA): • HopGuard® manufactured by BetaTec Hop Products. HopGuard® cardboard strips treated with potassium salt of hop beta acids may be inserted in honey bee colonies or packages of adult worker bees prior to installation in a honey bee colony. This exemption expires November 30, 2013.

Apivar® manufactured by Veto-Pharma
 S.A. Apivar® slow-release plastic strips contain the active ingredient, amitraz, which will release on contact with bees when strips are Beekeepers, continued on page 2

# EPA Announces Plan to Extend Sale and Use of MSMA

On September 30, 2009, the Environmental Protection Agency (EPA) announced the final decision regarding the use of MSMA for weed management, which provided means of phasing out the important herbicide by 2013. During the phase-out period, EPA would allow unrestricted use of MSMA on cotton and set use restriction guidelines for use on golf courses, sod farms, and highway rights-of-way.

Other important use sites were excluded by the decision, meaning MSMA would no longer be labeled or sold for use on residential turf, commercial turf, sports turf, forestry, non-bearing fruits and nuts, citrus (bearing and non-bearing), seed production (bluegrass, fescue and ryegrass), **MSMA**, continued on page 2

suspended in honey bee colonies. This exemption begins January 1, 2013, and expires December 31, 2013.

The varroa mite is a harmful, honey bee parasite that feeds on adult bees and developing brood. If left untreated, varroa mites can deform bees and eventually kill the colony.

The Mississippi Department of Agriculture and Commerce's Bureau of Plant Industry has authority under Section 18 of FIFRA to obtain an exemption from EPA for a nonlabeled use of a pesticide if significant losses of an agricultural commodity are likely and alternative, labeled products are not available

or effective.

drainage ditch banks, railroad, pipe line, utility rights-of-way, fence rows, or storage yards. Existing stocks of MSMA, however, could legally be used for weed control on these sites until exhausted, provided that these uses comply with the EPA-approved label and labeling of the affected product.

This decision by EPA was followed by a considerable amount of disappointment from the public, and after many public comments and appeals, EPA confirmed a new decision on September 14, 2012. The new decision extended the sale and use of MSMA for golf courses, sod farms, highway rights-of-way, and cotton under the same use restrictions for at least three years, or until further notice from EPA.

While MSMA will continue to be labeled and

sold for use on golf courses, sod farms, highway rights-of-way, and cotton, EPA has provided specific use restrictions for each:

- Cotton:
- No restrictions.

#### **Golf Courses:**

- · One broadcast application of MSMA allowed per year on newly constructed courses.
- · Only spot treatments allowed on existing courses.
  - \* Spots must be less than 100 feet.
  - \* Treat no more than 25 percent of course per year.
- \* Effective Date: September 14, 2012

## Sod Farms:

· Only two broadcast applications of

MSMA allowed per season.

· 25 foot buffer strip required for farms bordering permanent water bodies.

\* Effective Date: September 14, 2012

### Highway Rights-of-Way:

- · Two broadcast applications of MSMA allowed per year.
- · 100 foot buffer strip required when spraying near permanent water bodies.
- Effective Date: September 14,2012

## May I See Some Identification, Please?

Consumers often contact the Bureau of Plant Industry (BPI) to inquire if an individual is licensed to perform professional services in pest and weed control, landscaping, and tree surgery. As a potential client, it is very important to make sure the individual you hire is indeed licensed to perform these services. A license ensures he or she has met qualifications, passed required examinations, and possesses the necessary knowledge and expertise to perform quality work. To find out if a pest or weed control operator, landscaper, or tree surgeon is licensed, simply ask to see his or her identification card before any work is performed on your home or property. All license holders and their registered technicians are responsible for having their ID cards in their possession at all times when performing work or soliciting business.



### Current Pest and Weed Control ID Card

Individuals licensed to perform pest and weed control work carry an ivory ID card like the example shown above. All license holders in possession of this card qualified based on education, work experience, or a combination of both, and were required to pass a series of examinations based on his or her area(s) of specialization. This ID card enables an

### Current Pest and Weed Control Registered Technician ID Card

operator to legally purchase and use restricted-use pesticides for pest and weed control work.

License holders employ technicians to assist in pest and weed control activities, and these registered technicians carry a gray ID card like the example shown above. There are three categories of work **Identification Cards**, *continued on page 4*

that require specialized training before an ID card can be issued to a technician, which are: Wood Destroying Insect Control, General Pest and Rodent Control, and Fumigation Pest Control. Training is recommended for all other categories of work, but it is not required. To become a registered technician, the license holder must submit an application to BPI requesting a registered technician ID card for their employee(s) once they have met the training requirements, if required.

Individuals licensed in landscaping and tree surgery, along with their registered technicians, carry green ID cards like the example shown on the right. All license holders in possession of this card were required to pass an examination in his or her area(s) of specialization.

To simplify the process, BPI will begin issuing blue ID cards to all those who qualify for a license in any category of pest or weed control, landscaping, or tree surgery. Registered technicians will continue to carry gray ID cards, in-
